## NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

REGARDING: Roseville Digital Billboard Project - Initial Study/Mitigated Negative Declaration

Public Notice is hereby given that an Initial Study/Mitigated Negative Declaration (environmental report) for the Roseville Digital Billboard Project is available for public review.

**Project Location and Description:** The project site is located southwest of the intersection of I-80 and Douglas Boulevard, beyond the terminus of South Harding Boulevard, in the City of Roseville, CA. The project site, identified by Assessor's Parcel Number 014-183-029, is vacant and covered in dirt and ruderal grasses. The northern portion of the parcel has been used seasonally as a Christmas tree lot and the entire parcel has been used as a construction staging area by the Caltrans. Surrounding land uses include single-family residences to the west and southwest, a commercial area to the north, and I-80 and an associated on-ramp to the east and southeast. The project site has a General Plan land use designation of Community Commercial (CC) and is zoned Planned Development (PD192).

The proposed project would include the installation and operation of a two-side electronic sign at the eastern portion of the project site.

**Hazardous Materials and Hazardous Waste Sites:** The project site is not identified on any list of hazardous materials sites compiled pursuant to California Government Code Section 65962.5.

**Document Review and Availability:** The public comment period will extend 30 days from November 19, 2021, to December 20, 2021. The document can be viewed and/or downloaded from the City of Roseville website at the following link: www.roseville.ca.us/environmentaldocuments
