REGULATIONS FOR UNMANNED AIRCRAFT FLYING WITH PERMIT

The following conditions must be followed or the applicant risks losing all flying privileges

- **Referenced Ordinance: 8.02.300(A).** <http://qcode.us/codes/roseville/>
- No unmanned aircraft may be flown in any City park without a permit.
- For unmanned aircraft weighing more than .55 pounds, applicants must show certificate of proof of having their unmanned aircraft registered with the FAA before being issued a permit.
- Applicant must abide by the rules and regulations set forth by the FAA, <https://www.faa.gov/uas/>
- Only non-internal combustion powered & remote control models permitted.
- All unmanned aircraft must be under 55 lbs.
- Flying is permitted during daylight hours only.
- Flying is permitted only when no City sponsored programs or events are scheduled in the designated location.
- City sponsored programs have priority. This permit does not give you exclusivity to the park.

- I agree to abide by all the conditions outlined in this application and any permit(s) issued associated with this application.
- I also agree to pay the City of Roseville all costs the City may incur as a result of any failure to fully comply with all these conditions.
- I agree to indemnify and hold harmless the City of Roseville, its officers, agents, employees, and volunteers from and against any injury, damage, claims, actions or suits arising out of my use of Roseville City parks, including those caused by the passive negligence of the parties being indemnified and/or any dangerous condition of property of the parties being indemnified, and I further agree to defend and indemnify the City of Roseville from and against any injury, damage, claims, actions or suits arising out of or connected with the permit or use.

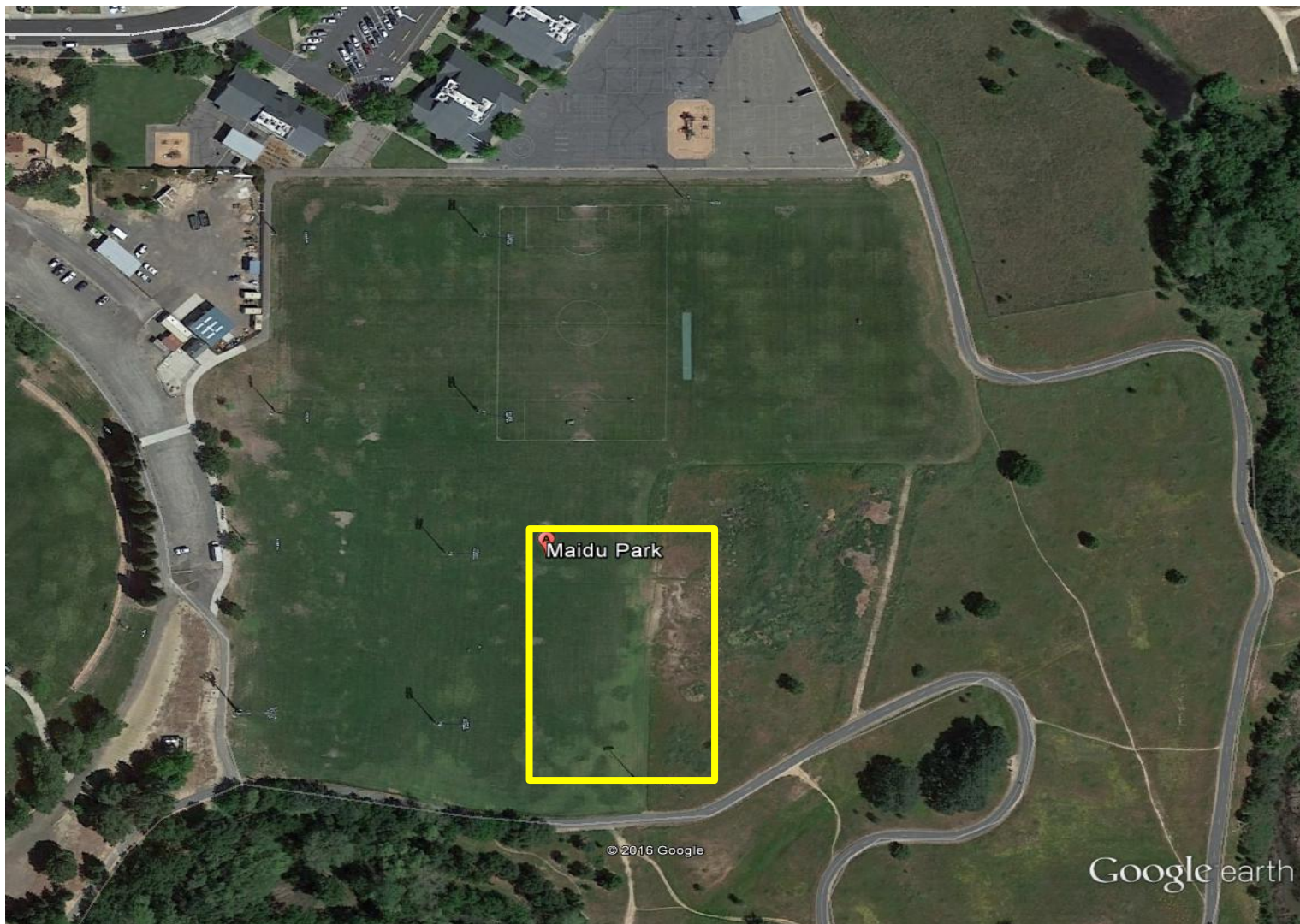
