  - Extend existing Pleasant Grove Creek Class I north to Painted Desert Court
  - Finish the little piece of Pleasant Grove Creek Class I just west of Woodcreek Oaks Boulevard
  - Finish the little spur that goes south from the Pleasant Grove Creek Class I towards Petersborough Way.
