## PUBLIC HEARING NOTICE

**NOTICE** is hereby given that on **January 19, 2006**, at 4:30 p.m., or as soon thereafter as the matter may be heard, the **Design Committee** of the City of Roseville will hold a Public Hearing at **The Civic Center (Meeting Rooms 1 & 2) located at 311 Vernon Street, Roseville, CA** for the purpose of considering an application for: <u>a</u> <u>DESIGN REVIEW PERMIT & ADMINISTRATIVE PERMIT - 212 RIVERSIDE AVENUE - PAUL BAKER PRINTING - DRP 03-66 & AP 05-01.</u>

**Nature of request:** The applicant request approval of a Design Review Permit to authorize construction of a single-story warehouse and office building totaling 5,456 square feet (4,796 square feet warehouse use and 660 square feet office use), with associated site improvements including parking and landscaping. An Administrative Permit is requested to authorize a parking reduction from the required eight (8) off-street parking stalls to three (3) parking stalls (a reduction of five parking stalls).

**Environmental Determination:** Construction of the building is categorically exempt from the environmental review requirements of the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15303 and the City of Roseville CEQA Implementation Procedures that exempt new construction of small structures. The parking reduction is exempt pursuant to Section 15305, minor alternations in land use limitations.

Following the Public Hearing, the **Design Committee** may take such action on the project as it deems appropriate. Interested persons are invited to submit written comments prior to and may testify at the Public Hearing. **Written comments may be submitted to the Project Planner, City Planning Department, 311 Vernon Street, Roseville, CA 95678.** If the matter is continued for any reason to a later date, written comments and public testimony will be accepted until the close of the final Public Hearing. All comments will be considered by the Approving Authority.

The **Design Committee's** action on the project may be appealed by any interested person to the City Council by filing a written appeal with the City Clerk within 10 days following the **Design Committee's** final action on the project. If the project is appealed to the City Council, the Council's action is final.

If you challenge the action of the **Design Committee** on this matter in court, you may be limited to raising only those issues you or someone else raised at the Public Hearing described in this notice, or in written correspondence delivered to the Planning Department at, or prior to the Public Hearing.
