# A. 3000 HAYDEN PARKWAY - FIDDYMENT RANCH PHASE 3 SPECIFIC PLAN AMENDMENT - DRAFT SUBSEQUENT ENVIRONMENTAL IMPACT REPORT - The applicant proposes to amend the West Roseville Specific Plan (WRSP) and revise the Land Use Plan to accommodate 1,905 additional residential units (580 Low Density Residential units, 609 Medium Density Residential Units, and 716 High Density Residential Units) in Fiddyment Ranch Phases 1, 2, and 3.
