ORDINANCE NO. 2653

ORDINANCE OF THE COUNCIL OF THE CITY OF ROSEVILLE APPROVING AN AMENDMENT TO THE DEVELOPMENT AGREEMENT WITH JOHNSON RANCH INVESTORS AND JOHNSON RANCH DEVELOPERS, AND AUTHORIZING THE CITY MANAGER TO EXECUTE IT ON BEHALF OF THE CITY OF ROSEVILLE

THE CITY OF ROSEVILLE ORDAINS:

SECTION 1. In accordance with Article 30 of Ordinance No. 802, the Zoning Ordinance of the City of Roseville, the City Council has received the recommendation of the Planning Commission that the City of Roseville enter into an Amendment to the Development Agreement with Johnson Ranch Investors and Johnson Ranch Developers for the Northeast Roseville Specific Plan Area.

SECTION 2. The Council of the City of Roseville has reviewed the findings of the Planning Commission recommending approval of an Amendment to the Development Agreement with Johnson Ranch Investors and Johnson Ranch Developers for property located in the Northeast Roseville Specific Plan Area and makes the following findings:

- 1. The Amendment to the Development Agreement is consistent with its objectives, policies general land uses and programs specified in the City of Roseville General Plan;
- 2. The Amendment to the Development Agreement is compatible with the uses authorized in and the regulations prescribed for the land use district in which the real property is located;
- 3. The Amendment to the Development Agreement is in conformity with public convenience, general welfare and good land use practice;
- 4. The Amendment to the Development Agreement will not be detrimental to the health, safety and general welfare of residents in the City of Roseville;
- 5. The Amendment to the Development Agreement will not adversely affect the orderly development of property or the preservation of property values; and
- 6. The development permitted by the Amendment to the Development Agreement is not significant enough to alter the benefit to the City of Roseville, justifying entering into the Amendment to the Development Agreement.

SECTION 3. The Amendment to the Development Agreement by and between Johnson Ranch Investors and Johnson Ranch Developers and

the City of Roseville, relating to property located in the Northeast Roseville Specific Plan Area is hereby approved and the City Manager is authorized to execute it on behalf of the City of Roseville.

SECTION 4. The City Clerk is directed to record the executed Amendment to the Development Agreement within 10 days of the execution of the agreement by the City Manager with the County Recorder's office of the County of Placer.

SECTION 5. This ordinance shall be effective at the expiration of 30 days from the date of its adoption.

SECTION 6. The City Clerk is hereby directed to cause this ordinance to be published in full at least once within 14 days after it is adopted in a newspaper of general circulation in the City, or shall within 14 days after its adoption cause this ordinance to be posted in full in at least three public places in the City and enter in the Ordinance Book a certificate stating the time and place of said publication by posting.
