**1) Designation of Chair**

Leilani Fratis was randomly selected by the City Attorney's office to serve as Chairperson for the June 16, 2016 Compliance Order Hearing Panel.

**2) Call to order**

Chairperson Fratis called the meeting to order at 9:00 a.m. in the City Hall Council Chambers.

**4) Public Comment**

No one from the public offered any public comment.

Chairperson Fratis confirmed her selection as Chairperson, administered the Oath, reviewed the agenda, and the procedures for the compliance order.

**5) Compliance Order**

Issued to James Kin Sing Watt Trustee for the violation of Roseville Municipal Code section 16.35.110 (13), Substandard Buildings, and for the violation of Roseville Municipal Code section 10.54.020 (A)(2), No substantial work on the project for a period of six (6) months.

**d. Panel discussion/decision:**

**Violations**

**Roseville Municipal Code Section 16.35.110(13)**

The panel discussed the evidence and testimony presented before them at the hearing in regards to Roseville Municipal Code section 16.35.110(13).

Motion by Pete Constant, and seconded by Bruce Hagler that a violation of Roseville Municipal Code section 16.35.110(13) did occur at the thirteen (13) buildings as of the date of the Compliance Order and the required corrective action did not take place within the fourteen (14) day required time period in the Compliance Order. This is based on the testimony of the Building Official and Building Inspector, written reports submitted, written statements by the parties in the various letters submitted, and other evidence and witness testimony received at the hearing. The panel reasoned that testimony and admissions by the parties showed that without temporary shoring the thirteen (13) buildings are dangerous and an immediate threat to life/safety. Additionally, the panel reasoned that the City did not receive the requested information in the Compliance Order to know whether the shoring was safe or not before the date of the June 16, 2016 hearing.

## **Roseville Municipal Code Section 10.54.020(A)(2)**

The panel discussed the evidence and testimony presented before them at the hearing in regards to Roseville Municipal Code section 10.54.020(A)(2).

Motion by Pete Constant, and seconded by Bruce Hagler that the violation of Roseville Municipal Code section 10.54.020(A)(2) occurred at the thirteen (13) buildings as of the date of the Compliance Order and the required corrective action did not take place within the fourteen (14) day required time period in the Compliance Order. This is based on the testimony of the Building Official and Building Inspector, written reports submitted, written statements by the parties in the various letters submitted, the evidence and testimony of the multiple expired buildings permits, and other evidence and witness testimony received at the hearing. The panel reasoned that the evidence of the multiple expired building permits and long periods of time with no substantial construction met the definition of abandonment under 10.54.020(A)(2). The written reports, testimony, and admissions by the parties showed that the thirteen (13) buildings have sat for approximately two (2) years without substantial work being completed on them.

### **Order to Correct**

The panel discussed the evidence and testimony presented at the hearing. Assistant City Attorney Michelle Sheidenberger answered questions from the panel.

Motion by Pete Constant, seconded by Bruce Hagler that the Order to Correct directs James Kin Sing Watt Trustee to:

Provide a single, comprehensive structural engineer's written report summarizing the information in the previous reports and testimony provided at the June 16, 2016 hearing regarding the current condition of the temporary shoring at the thirteen (13) buildings, whether the shoring requires any repairs or remediation, and a timeline for how long the shoring can remain in place. The comprehensive report is to be wet stamped (electronic submission is acceptable) and submitted to the City of Roseville's Building Division for approval within twenty-one (21) days of the June 16, 2016 hearing; and

By October 1, 2017, have a structural engineer re-inspect and evaluate the remaining shoring and provide a written report with an evaluation of the condition of the temporary shoring that remains in place, whether the shoring requires any repairs or remediation, a timeline for completion of any repairs and remediation, and a timeline for how long the shoring can remain in place. This report is to be wet stamped (electronic submission is acceptable) and submitted to the City of Roseville's Building Division by no later than fourteen (14) days from the date of the shoring inspection; and

Have all plans submitted, permits issued, and final permit sign-offs for the remaining thirteen (13) buildings (400, 401, 410 Rocky Pointe and 401, 405, 415, 420, 425, 435, 444, 446, 448 and 450 Forest Knoll) by no later than January 31, 2017; and

Within twenty-one (21) days of the June 16, 2016 Compliance Order hearing, a proposed construction schedule that ensures compliance by January 31, 2017 be submitted for approval to the City of Roseville's Building Division.

### **Administrative Penalties**

In conjunction with the Compliance Order, the following administrative penalties were assessed:

Fifty dollars (\$50) per day, per building for all thirteen (13) buildings, from May 12, 2016 to June 16, 2016 (35 days), totaling twenty-two thousand, seven hundred and fifty dollars (\$22,750.00) due and payable immediately; and

Fifty dollars (\$50) per day, from May 12, 2016 to July 7, 2016 (57 days) held in abeyance, due if the engineer's report is not received by the Building Division in compliance with the order by July 7, 2016 (twenty-one (21) days from the June 16, 2016 hearing); and

Fifty dollars (\$50) per day, per building for all thirteen (13) buildings, from June 17, 2016 to January 31, 2017, held in abeyance until February 1, 2017, payment due in full if plans have not been submitted, permits issued, and final permit sign-offs received for any of the remaining thirteen (13) buildings (400, 401, 410 Rocky Point and 401, 405, 415, 420, 425, 435, 444, 446, 448, and 450 Forest Knoll) by January 31, 2017 (228 days); and

One hundred dollars (\$100) per day, per building, beginning February 1, 2017 for any of the remaining thirteen (13) buildings (400, 401, 410 Rocky Point and 401, 405, 415, 420, 425, 435, 444, 446, 448, and 450 Forest Knoll) that does not have all plans submitted, permits issued,

and final permit sign offs until such conditions are satisfied or the sum of fifty thousand dollars (\$50,000), per building, has accrued.
