To qualify for a rebate, the applicant must:

- Be the property owner of record or a legally authorized representative.
- Submit a completed application form
- Participate in a pre-conversion site visit with a City representative and receive City approval before work is performed.

Following the pre-conversion site visit:

- Purchase, installation and programming of the smart timer must be made in accordance with the terms and conditions of the rebate program within the required time period.
- Schedule a post-conversion site visit with a City representative once installation and programming have been completed and provide representative with paid itemized receipts.

In addition to the foregoing qualifications, I declare that I am the property owner of record or a legally authorized representative and that I have been provided with a copy of the Smart Timer Rebate Program Terms and Conditions. I have read, understand and agree to the Terms and Conditions which are incorporated herein by reference.

Residential Smart Timer Rebate Program Terms and Conditions

1. Any eligible irrigation timer must be purchased and installed between July 1, 2014 and June 30, 2015.
2. Participants must be a City of Roseville water customer and the property owner of record. Roseville residency not required.
3. New construction does not qualify.
4. Customer must have a water meter installed and billed on a metered rate to be eligible.
5. Customer must have an existing automated irrigation system with an operable irrigation controller that has, at minimum 3 active stations.
6. Irrigated turf area is greater than 300 sq ft.
7. Participants agree to install, maintain, and manage the use of the smart timer for a minimum of 3 years. Participant agrees to give the City of Roseville permission (with a scheduled appointment) to enter the property for the purpose of conducting the mandatory installation verification and reviewing and/or modifying the smart timer programming.
8. Once the old irrigation timer is replaced, participants agree to relinquish the old irrigation timer to City staff at the time of post-conversion inspection.
9. If your property's landscape is maintained by an HOA, a letter of approval to participate and acknowledgement of the program terms is required from the HOA.
10. If smart timer purchased requires a subscription service to operate effectively, participant agrees to purchase the signaling fees for a minimum of 3 years prior to receiving the rebate.
11. Related equipment that upgrades standard irrigation timers to smart timers are eligible for funding. This may include sensors and weather stations. Maximum rebate amount is \$150 for this equipment.
12. Participants agree that participation in this program does not exempt them from any water use ordinances that may become or already is in effect, including imposing landscape watering restrictions during periods of drought.
13. Participant agrees to release pre- and post-installation water use records for program statistical purposes.
14. The maximum rebate amount is \$150 for a 4-station timer plus \$25 for each additional station up to \$200. Rebate amount shall not exceed the purchase price of the controller. Rebate shall be given for water efficient product material only. Items such as wiring, electrical tape, etc. are excluded from rebate funding. Participants are eligible for one rebate per meter.
15. If controller is installed and programmed by a licensed, certified landscape contractor, up to \$50 of the labor cost can be reimbursed.
16. Customer must agree to a pre-conversion site visit before any work is performed.
17. Applicant must complete project within 60 days of pre-conversion site visit.
18. Only Smart Irrigation Controllers tested under the Irrigation Association's Smart Water Application Technologies protocol ("SWAT tested") and meet the City of Roseville eligibility standards qualify for the rebate. A list of qualified models is attached.
19. Itemized receipts and/or detailed contractor paid invoices are required.
20. If labor reimbursement is requested, timer must be installed by a CA State licensed landscape contractor holding a C27 or a D12 specialty license AND a business license with the City of Roseville. Contractor must also leave an irrigation program for the homeowner that provides a schedule for the landscape. The City recommends that the contractor be a certified California Landscape Irrigation Auditor (CLIA). To find a certified auditor visit: <http://irrigation.org/hirecertified/>
21. Rebate program is subject to available funding. Rebates will be distributed on a first-come, first-served basis until funding is depleted. Submission of an application does not guarantee a rebate.
22. City reserves the right to modify or cancel the program at any time.
23. The program is designed to rebate a portion of the costs of timer upgrades and to encourage good water management.
24. Cost per unit must not exceed manufacturer's suggested retail price (MSRP).

Smart Timer Qualifying Products List July 1, 2014

Only specified Smart Water Application Technology (SWAT) tested timers qualify for the City of Roseville's Smart Timer Rebate Program.
