BACKGROUND

Pursuant to the recently adopted legislation known as AB1-X 26, the newly formed Oversight Board is required to elect a Chairperson to preside over its meetings. Although not required, it is recommended a Vice Chairperson also be elected in cases of an absence by the Chair. Staff recommends a one-year term be adopted.

Suggested Voting Procedure:

All actions must be taken with a majority vote of the entire Oversight Board. As the Board composition is required to have seven (7) members, four (4) affirmative votes will satisfy a quorum and majority vote.

As there is currently no Chair or Vice Chair, staff will open and close nominations to the Oversight Board for each position. The Recording Secretary will then distribute the ballots. The results of the balloting, including whom each member selected for Chair and Vice Chair will be read aloud. A vote will be taken formalizing the election of both the Chairperson and Vice Chairperson.

BACKGROUND

According to the newly authorized California Health and Safety Code §34179(f):

The Department of Finance (DOF) may review an Oversight Board action taken pursuant to the act adding this part. As such, all Oversight Board actions shall not be effective for 3 business days, pending a request for review by the department. Each Oversight Board shall designate an official to whom the department may make such requests and who shall provide the department with the telephone number and e-mail contact information for the purpose of communicating with the department pursuant to this subdivision. In the event that the department requests a review of a given Oversight Board action, it shall have 10 days from the date of its request to approve the Oversight Board action or return it to the Oversight Board for reconsideration and such Oversight Board action shall not be effective until approved by the department.

Staff recommends designating the Housing Programs Manager, Jan Shonkwiler, of the Successor Agency/City of Roseville as the official contact for the DOF. Upon receiving an inquiry, the Housing Programs Manager will then identify the most appropriate staff that could address the concerns identified by the DOF in order to respond to these inquiries.

Once the Oversight Board has approved this action, staff will communicate the selection of the Housing Programs Manager as the official contact to the DOF.
