A Multi-Use Trail Along Dry, Cirby, and Linda Creeks From Riverside Avenue to Old Auburn Road

Public Notice: Notice is hereby given that the City of Roseville, Alternative Transportation Division, has prepared a Draft Environmental Impact Report (EIR) for the proposed Dry Creek Greenway East Trail Project – a multi-use trail along Dry, Cirby and Linda Creeks from Riverside Avenue to Old Auburn Road.

Project Description/Location: The proposed 4.25-mile multi-use trail would follow open space corridors along portions of Dry, Cirby, and Linda Creeks and would extend from the existing Saugstad/Royer Park trail near the intersection of Riverside Avenue and Darling Way eastward to the City limits, just past the Old Auburn Road/South Cirby Way intersection. The typical cross-section would consist of a 10-foot wide paved trail with two-foot shoulders for a total width of 14 feet. The proposed project would include the undercrossing of existing roadways, including Darling Way, Interstate 80, Sunrise Avenue, Rocky Ridge Drive, and Old Auburn Road. The project would also include construction or modification of up to eight bridges to provide creek crossings and would require retaining walls at several locations due to existing topography. Finally, the project could include elements such as trail head parking, benches, lighting for under crossings, utility relocations, and regulatory and wayfinding signs, and would also be designed to support City utility maintenance and emergency access.

Lead Agency: City of Roseville is serving as CEQA Lead Agency for the project.
