Incomplete applications will be rejected, thus delaying issuance of a Dance Permit. One Time / Special Event dance permits shall expire at the conclusion of the event/dance for which the permit was issued.

It is unlawful for any applicant to hold a public dance without first obtaining a valid Public Dance Permit.
